

STATEMENT OF LIMITED WARRANTY FOR PURO PRODUCTS 02/2020

THANK YOU FOR PURCHASING YOUR PURO™ LIGHTING PRODUCT, POWERED BY VIOLET DEFENSE™ TECHNOLOGY.

THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

PURO LIGHTING ("COMPANY") WARRANTS THE PRODUCT TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP UNDER NORMAL USE FOR A PERIOD OF ONE (1) YEAR FROM THE DATE OF PURCHASE, AS EVIDENCED BY THE PROOF OF PURCHASE (THE "WARRANTY PERIOD"). COMPANY LIMITS THE DURATION AND REMEDIES OF ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE TO THE DURATION OF THE FOREGOING EXPRESS LIMITED WARRANTY. SOME STATES MAY NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU. OUR RESPONSIBILITY FOR DEFECTIVE GOODS IS LIMITED TO REPLACEMENT AS DESCRIBED BELOW IN THIS STATEMENT OF LIMITED WARRANTY.

WHO MAY USE THIS WARRANTY?

Company extends this limited warranty only to the customer who originally purchased the Product from Company. This warranty is non-transferrable and is not intended for the benefit of any person or entity other than the original purchaser.

WHAT DOES THIS WARRANTY COVER?

This limited warranty covers defects in materials and workmanship of the Product under normal use for the Warranty Period.

WHAT DOES THIS WARRANTY NOT COVER?

This limited warranty does not cover any nonconformance due to external causes such as: (1) acts of nature; (2) physical damage; (3) exposure to water either through submersion or water entering the unit; (4) exposure to adverse or hazardous chemicals, including the use of reactive cleaning agents or harsh chemicals to clean the Product; (5) environmental conditions; (6) vandalism; (7) fire; (8) power failure, improper power supply, power surges or dips; (9) induced vibration; (10) negligence or more culpable conduct by the purchaser, its employees, contractors, representatives or other users of the Product; (11) improper or unauthorized use, installation, handling, storage, alteration, maintenance or service, including failure to abide by any product classifications or certifications, or failure to comply with any applicable standards, codes, recommendations, product specification sheets, instructions, and safety warnings; (12) use of the Product(s) with other products, equipment, processes or materials supplied by any end user or

third party; or (12) any nonconformance caused in whole or in part by occurrences beyond Company's control.

WHAT IS THE PERIOD OF COVERAGE?

This limited warranty starts on the date of your purchase of the Product and lasts for one year. The Warranty Period is not extended if we replace the Product. Company may change the availability or terms of this limited warranty at its discretion, but any changes will not be retroactive.

WHAT ARE YOUR REMEDIES UNDER THIS LIMITED WARRANTY?

During the Warranty Period, if the Product fails to conform to the foregoing warranty, the Company, at its sole discretion, will replace the Product (or the defective portion thereof). The foregoing warranty excludes labor and equipment required to remove the non-conforming Product (or part(s) thereof) and/or re-install the replacement Product(s) (or part(s) thereof).

HOW DO YOU OBTAIN WARRANTY SERVICE?

Warranty claims must be submitted in writing to Company within thirty (30) days of the discovery of the nonconformance, or the nonconformance will be deemed to have been waived. To obtain warranty service, you must call (877) 452-8785 during the Warranty Period to obtain a Return of Materials Authorization ("RMA") number. No warranty service will be provided without an RMA number.

The nonconforming Product(s) may be required to be returned to Company for inspection and verification of the nonconformance. Company will not be responsible for any costs and expenses incurred in connection with shipment of the nonconforming Product(s) (or part(s) thereof) to Company, however, Company shall bear the expenses of shipping the replacement Product(s) (or part(s) thereof) to the purchaser in the event that Company elects to replace the Product(s) (or part(s) thereof).

LIMITATION OF LIABILITY

THE REMEDIES DESCRIBED ABOVE ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND OUR ENTIRE LIABILITY FOR ANY BREACH OF THIS LIMITED WARRANTY. OUR LIABILITY SHALL UNDER NO CIRCUMSTANCES EXCEED THE ACTUAL AMOUNT PAID BY YOU FOR THE NONCONFORMING PRODUCT, NOR SHALL WE UNDER ANY CIRCUMSTANCES BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES OR LOSSES, WHETHER DIRECT OR INDIRECT.
